The Wildcat Premier track meet was on March 31. Laura Barnett coordinated volunteers. Overall, the event went very well. There were issues with the grills that we use and Laura will talk to the Touchdown Club so they can be resolved prior to the OCC track meet. Approximately 480 hot dogs, 160 brats, 160 hamburgers, and 50 gallons of hot chocolate were served. However, we ran out of soft pretzels, blew some fuses, and didn't have the same number of hot dog buns as we did hot dogs.

There were problems with the restrooms at the Wildcat Premier again this year. Due to the large number of athletes and spectators, there were issues with cleanliness, overflowing, etc. This seems to be an ongoing concern, even though Laura Barnett, Ann Mascotti-Bowman, and Heidi Smith spent time disinfecting and cleaning up throughout the day. It was suggested that the Boosters paint the restrooms over the summer, in addition to the away concession stand (may be done by a student for an Eagle Scout project).

We had volleyball concessions of \$374.00 (gross), thanks to the Sheely's staffing on March 24 for a tournament.

Davidson will be hosting the OCC track meets on May 10 and May 12. These are all-hands-on-deck events, so mark the dates on your calendar and be prepared to volunteer in concessions (and find volunteers on your teams to help too).
